

# NWMPC Membership Application Instructions

Thank you for your interest in our club, we are an educational & fun nonprofit that has been promoting small scale mining and prospecting for over 40 years now. This Membership application is used for our Membership Renewals also.

- 1.) **New Membership Fee of \$45** will get you your club Membership Packet which includes our Club Manual that has all of our Club's Bylaws, directions and maps to our club claims and our Club Ribbon to hang in your vehicle to identify that you're a club member while you are on our club claims, you still may need to show your club I.D. card. If asked by a club member.
- 2.) **New Member Manual/Packet (U.S.P.S. mailing) (optional) Fee \$5.00** is for mailing your new Membership Packet to you. You are not required to have the packet mailed to you and you can always pick up your New Membership Packet at the next Club Business Meeting which is typically on the second Tuesday of every month at 7PM.
- 3.) **Membership Renewal Fee \$30.00** is for current club members that are renewing their membership. We can now accept payments for a 1, 2 or 3 year Membership renewal as a convenience to our members.
- 4.) **NWMPC Equipment & Book Library (optional one time) Fee \$10.00** gets you access to our club's vast library of mining books and videos as well as some small mining equipment that you can check out for a month to use. You can add the Library option at any time; it doesn't have to be done at this time.
- 5.) **Printed NWMPC Newsletter (U.S.P.S. annual mailing) (optional) Fee \$18.00** is to have a printed copy of our Clubs Monthly Newsletter mailed to you. We can now accept payments for a 1, 2 or 3 year Newsletter Postage as a convenience to our members.
- 6.) **Emailed NWMPC Newsletter (Free) Yes No \$0.00** is to indicate that you wish to receive our clubs monthly newsletter emailed to you at no cost. If you choose to have a printed newsletter mailed to you each month for \$18/year you can also have a newsletter emailed so you will receive both newsletter versions.

- 8.) **Payment Method** Cash, Credit Card, Check or Square Invoice
- 9.) **Would you like us to Invoice you for your payment via Square Invoice**, as a convenience to our club members we also offer the option to pay your club Membership dues/fees using Square Invoices. If you choose to use this option, fill out the front and back side and total all the options you want and then initial and sign the back of the form and mail this completed application to the address on the top of the Membership Application.

If you have chosen to be invoiced for your membership dues and when we receive your completed Membership Application by mail we will generate a Square Invoice that will be sent to the Email address you provide us. When you receive the Square Invoice follow the directions which will take you to the secure SQUARE website for credit card processing. Once you have completed the transaction your receipt will be emailed to you.

**10.) Waiver of Liability and Assumption of Risk Agreement for Use of NWMPC Mining Claims** on the reverse side of the Membership Application will also need to have each section initiated and then signed and dated.

You may also bring in your completed Membership Application the next monthly Business Meeting on the second Tuesday of every month at 7PM and pay in person by cash, check or credit card.
